Uniform Policy

Aims and objective

It is our school policy that all children wear school uniform when attending school, or when participating in a school-organised event, during or outside normal school hours. We want all our children to look smart when at school and feel proud to wear their uniform.

Whilst wearing school uniform children are expected to behave in a manner which positively reflects the school at all times.

Our children should wear a uniform because:

- ▶ Our uniform identifies us as a community and reinforces our culture of high expectations and raising standards in academic achievement.
- ▶ Uniform unites us as a community: we learn, practice, play and succeed together.
- ▶ Uniform reduces distractions: we are focused on our learning.
- ▶ Uniform makes us all equal: we come to school looking the same way; no one has to feel awkward about the clothes they have or don't have.
- ▶ Uniform gives us all an identity to be part of and proud of.
- ▶ Uniforms are professional

All other items can be purchased from any High Street store or supermarket. We also offer **optional** Edith Cavell book-bags, PE bags, baseball caps and beanie hats.

Winter Uniform - Autumn & Spring Terms

- ▶ Blue Edith Cavell logo sweatshirt/cardigan
- ▶ White polo shirt
- ▶ Grey trousers/skirts
- ▶ Summer dress (blue/white)
- ▶ Black sensible shoes - NOT trainers

Optional Summer Uniform

- ▶ Grey shorts
- ▶ Summer dress (blue/white)

P.E Kit

- ▶ Black shorts/jogging bottoms
- ▶ White t-shirt
- ▶ Plain jumper
- ▶ Trainers/plimsolls that fit well

Footwear

We expect all children to wear plain flat black shoes in school (No trainers). Children can wear flat boots to school but they need to change into black shoes or black pumps to wear inside the school building. Flat black sandals can be worn in summer. Footwear should not have any adornments such as logos, fur, braid, beads etc.

As all children will be wearing the same items of clothing, parents must ensure that all items are **clearly labelled** with the child's name.

Hair, Jewellery and accessories

- ▶ No jewellery allowed except for a watch and only small, plain studs if children have pierced ears. These must be removed, by the child, for PE.
 - Medical identification bracelets may be worn by children who have significant medical problems eg. Diabetes or epilepsy.
- ▶ Watches - to be analogue or digital. No smart watches.
- ▶ Hair accessories are to be kept to a discreet minimum and in blue - neither large bows nor headbands with decorative pieces are allowed.
- ▶ Dyed hair or shaved tramlines are not allowed.
- ▶ Nail varnish should not be worn in school.
- ▶ Make up is not allowed

Other items

- ▶ Children should have a coat, preferably with a hood,
 - In winter children are permitted to wear a hat/ear-muffs, scarf and gloves. Please ensure that all items are clearly named.
- ▶ A school bag,
- ▶ Wellies for Foundation
- ▶ In the summer all children should have a sunhat
 - all to be provided from home and named.

Expectations

We expect all pupils to wear the correct uniform and comply with our uniform policy while:

- ▶ On the school premises
- ▶ Travelling to and from school
- ▶ We will continuously monitor the uniform standards and failure to comply will be brought to the attention of the Head teacher.

The Role of Parents

Parents and carers are expected to ensure their child has the correct uniform. Every item is:

- ▶ Clean
- ▶ Clearly labelled
- ▶ In good condition

The role of staff

Staff support the Leadership Team in maintaining high standards of uniform dress. They are role models in the wearing of appropriate clothing (including on trips). Where pupils fail to wear the correct uniform, staff will make discreet and sympathetic enquiries. Where pupils are wearing the correct uniform, staff will give positive encouragement. Staff are also aware that sometimes a pupil's standard of dress may indicate care issues at home. If this is suspected, it will be referred to a Designated Safeguarding Lead (DSL).

The Role of Governors

The governing body supports the Head teacher in implementing the School Uniform Policy. It considers all representations from parents regarding the uniform policy and liaises with the Head teacher to ensure that the policy is implemented fairly and with sensitivity. It is the governors' responsibility to ensure that the school uniform meets all regulations concerning equal opportunities. Governors ensure that the school Uniform Policy enables children to dress sensibly, in clothing that is hardwearing, safe and practical.
